ASI invites EOI from interested individual/agencies/companies/consortium those who had working experience of similar nature and are sufficiently capable and competent to provide facility management services in respect of the below mentioned facilities at various Centrally protected ASI monuments/sites and site Museums. EOI is invited from interested service providers to express interest and submit proposals in accordance with the purpose of this EOI.

**Proposal of the participants will be evaluated based on the professional experience, financial soundness and detailed financial evaluation of the various terms and conditions submitted by the participants in their proposals.**

The areas in which visitor amenities would need to be provided on a non-exclusive basis in one or more of the followings:-

1. electronic information delivery about the monument and its history in a user friendly story telling mode using contemporary technology and information dissemination on emergency contacts, other nearby monuments etc.,
2. Virtual Reality based 3D walkthrough of the monument,
3. VFX or other equivalent technology based 3D projection show depicting the story around the monument,
4. provision of caps, shoe wraps and audio guides for the monument,
5. video guides for various spots of the monument,
6. role based din & bustle at various spots of the monument based on historical story and the time of the day,
7. cleanliness of the monument,
8. 3D movie based story of the monument to be displayed in the site museum,
9. cloak room & washroom facilities near the ticket counters,
10. providing turnstiles at the entry and exit points with seamless integration with ASI's e-ticketing system,
11. providing ATMs at the entry / exit points,
12. providing memento and souvenir shop at designated space, Book Store
13. providing refreshment facilities for the visitors at designated space,
14. providing, running and maintenance services for battery operated vehicles for the use of visitors at the monuments,
15. providing free parking facilities for the visitors,
16. providing valet parking services for the visitors with high value tickets,
17. providing free Wi-Fi facilities for the visitors,
18. providing drinking water and first aid facilities at designated place near the monument,
19. providing carpets at designated spaces in and around the monuments etc.
20. Any other innovative proposal to enhance the popularity of the monument and bring it at par with world renowned places.
